## INSTRUCTIONS FOR CSFA ENROLLMENT FORM

**Resident Information**: This section includes several required pieces of information, particularly the general contact information for you and your spouse, including cell phone numbers and email addresses. Your enrollment in the program will not be finalized until this form is submitted with all required components completed. The information provided in this section will be used by the patrol officers in the event of an emergency and by the operating committee for periodic mailings, email broadcasts and other business matters. Please clearly label cell phone numbers and email address for each participant.

**Emergency Contact Information**: In the event of an emergency at your home, the patrol officer will always contact you as soon as possible. In the event that the patrol officer cannot reach you or other members of your immediate family listed, he or she will contact your designee(s) listed in this section. Your emergency contact can be a family member, a friend, or a neighbor that can help security personnel assess suspicious or criminal activity at your home.

**Alarm Service Information**: This information allows patrol personnel to contact your alarm company when responding to an active alarm at your home. The phone number provided should be for your alarm monitoring service, rather than your alarm repair service. If your alarm monitoring company requires a passcode to discuss alarm incidents, please provide the passcode for the officers.

Billing Preference: Please specify how you wish to settle your account with the Crestwood Security Fund Association: quarterly or annually. Invoices will be mailed to your billing address on the first of the month preceding the beginning of a new quarter. The due date of your payment is on the last day of the month prior to the new quarter. Please be prompt in your payment or penalties will be incurred. You may pay your invoice via check or online payment. Payment instructions will be included on your invoice. For your convenience, you may set up an automatic draft of your bank account to pay your invoice. In order to help us minimize time spent chasing unpaid invoices, we prefer you choose this method of payment. To do so, please contact our financial accountant (information on invoices).
